Taxable Earnings ko tena uiga ko te aofai peofuga katoa ne maua MAI MUA e 'kati a lafoga ako te PAYE e fakaasi te aofai lafoga ko oti ne togi ne koe mo te tausaga fakalafoga tenei.

Fakailoga Lafoga (Tax Code) e fakaasi ki tou pule me e fia te lafoga e 'tau o 'kati mai i tou peofuga.

Pasene Lafoga (Tax Rate) a koe e galue tou lafoga ki te 10.5%. Te mea nei se pasene fakapitoo mo tino galue RSE ko koe ke se manakogina o fakatagi ke toe togi mai o lafoga silia manafai ko oti tau galuega.
